NOORD-HOLLAND DISTRICT COURT

Trade, Subdistrict and Insolvency

Insolvency number: C/15/19/106 F

Ruling pursuant to Section 64 of the Bankruptcy Act in the case of bankruptcy of:

Jet Airways (India) Limited,

was declared bankrupt in a judgment by this district court on 21 May 2019, appointing R. Mulder LLM, as administrator in bankruptcy, and J.J. Dijk LLM, as supervisory judge;

The supervisory judge in the bankruptcy of Jet Airways (India) Limited, and charged as such with supervising the administration and liquidation of the bankrupt estate, has cognizance of the judgment (Company Appeal (AT) Insolvency no. 707 of 2019) of the "National Company Law Appellate Tribunal New Delhi", dated 26 September 2019, in the case of Jet Airways (India) Ltd. (Offshore Regional Hub/Offices Through its Administrator Mr. Rocco Mulder) vs State Bank of India & Anr., as well as of the "Cross Border Insolvency Protocol".

The administrator in bankruptcy has petitioned the supervisory judge to approve the conclusion of the agreement between A. Chhawchharia, in his capacity as Resolution Professional of Jet Airways (India) Limited, and R. Mulder, in his capacity as administrator in bankruptcy, as established in the Cross Border Insolvency Protocol.

DECISION

R. Mulder LLM, in his capacity as administrator in bankruptcy, has the authority and is hereby authorized to conclude the agreement established in the Cross Border Insolvency Protocol.

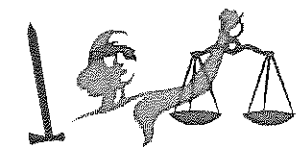

die bij vonnis van deze rechtbank van 21 mei 2019 in staat van faillissement is verklaard, met benoeming van mr. R. Mulder tot curator en mr. J.J. Dijk tot rechter-commissaris:

De rechter-commissaris in het faillissement van Jet Airways (India) Limited, en als zodanig belast met het toezicht op het beheer en de vereffening van de failliete boedel, heeft kennis genomen van de uitspraak (Company Appeal (AT) Insolvency no. 707 of 2019) van het "National Company Law Appellate Tribunal New Delhi" van 26 september 2019 in de zaak van Jet Airways (India) Ltd. (Offshore Regional Hub/Offices Through its Administrator Mr. Rocco Mulder) en State Bank of India & Anr., alsmede van het "Cross Border Insolvency Protocol".
